## **Synergy Acquisition Corp. Announces Non-Brokered Private Placement**

MONTREAL, QUEBEC--(Marketwired - Dec. 23, 2013) - Synergy Acquisition Corp. (the "**Corporation**") (CNSX:QMP) is pleased to announce a non-brokered private placement (the "**Private Placement**") of 2,545,000 units (the "**FT Units**") at a price of \$0.20 per FT Unit. Each FT Unit consists of one common share of the Corporation issued as a "flow-through share" and one non flow-through common share purchase warrant (the "**Warrant**"). Each Warrant is exercisable to acquire one common share of the Corporation that is not a "flow-through share" ("**Common Share**") at an exercise price of \$0.30 per Common Share for a period of 24 months after the date of closing of the transaction. Proceeds of the flow-through private placement will be used for Qualifying Canadian Exploration Expenses. The Private Placement also includes 21,111 non flow-through units (the "**Units**") at a price of \$0.18 per Unit. Each Unit consists of one common share of the Corporation and one common share purchase warrant.

The Corporation will pay a finder's fee equal to 10% of gross proceeds in cash and issue finder warrants share purchase warrants of the Corporation (the "**Finder's Warrants**") to the Finder equal to 10% of the Units and FT Units subscribed for by persons introduced to the Corporation by the Finder. Each Finder's Warrant will be exercisable to purchase one additional common share at \$0.18 per share for a period of one (1) year from closing.

All securities issued in the Private Placement will be subject to a four-month hold to April 28, 2014, pursuant to applicable securities laws.
