Super Nova is a Canadian resource exploration company engaged in the acquisition, exploration and development of mineral properties as well as oil and gas properties. The Issuer currently holds interests in resource properties in British Columbia and Quebec, Canada, and Montana, United States. During the month of July 2013 the Issuer did not conduct any significant exploration work on its resource properties due to the limitation of financial resources.

The Issuer was formed on October 2, 2012 upon completion of an amalgamation between 0922519 BC Ltd. (an issuer reporting in BC, Alberta and Ontario) and Super Nova Minerals Corp. (a private issuer). Effective October 22, 2012, the common shares of the Issuer were listed and commenced trading on the CNSX.

During the month of July 2013 management was mainly engaged in seeking potential new funding for the issuer.
