The Issuer is working to advance its Kolwezi project in the DRC.

The Issuer's subsidiary, Kolwezi Copper Corp. ("KCC"), acquired three additional exploration permits in the Democratic Republic of the Congo ("DRC"). The permits are situated in the copper-cobalt rich Kolwezi District located in Katanga Province – the heart of the Central African Copperbelt.

Through its wholly owned DRC operating subsidiary Minière du Congo SPRL ("MDC"), KCC acquired exploration permits PR 12717, PR 12718 and PR 12719 from the République Democratique du Congo Cadastre Minier. Each exploration permit carries an initial term of five years and two renewal options for an additional five years each. Upon each renewal, the Company would be required to relinquish 50% of the perimeter of the particular permit. Permitted exploration includes Copper, Cobalt and Gold. In order to maintain the validity of the permit, MDC must begin work within six months and pay annual area taxes. There are no minimum work requirements and the permits are 100% owned by KCC's Congolese subsidiary.
