UTMI (“the Lender”) has agreed to make a non-convertible loan in the amount of USD \$150,000.00 to Wedge Energy International Inc.(“the Borrower”) and as security therefor, the Borrower has agreed to provide the Lender with a general security agreement whereby the Borrower grants to Lender a security interest in all of the Borrower’s present and after-acquired personal property.
