On May 20, 2016 the Acquiror subscribed for 104,500 units (“**Units**”) in the first tranche of a private placement of the Issuer at a price of \$0.05 per Unit (the “**Offering**”). Each Unit is comprised of one Common Share and one-half of one Common Share purchase warrant (each whole warrant, a “**Warrant**”).

Item 3 – Interest in Securities of the Reporting Issuer

The Acquiror acquired 104,500 Units of the Issuer. The Units are comprised of 104,500 Common Shares and 52,250 Warrants. The 104,500 Common Shares and 52,250 Warrants, comprising the Units, represent approximately 0.70% of the issued and outstanding Common Shares of the Issuer and 5.49% of the Warrants issued pursuant to the first tranche of the Offering, respectively.

Prior to the completion of the first tranche of the Offering, the Acquiror, directly and indirectly, owned 2,896,500 Common Shares of the Issuer representing approximately 22.20% of the issued and outstanding Common Shares of the Issuer.

Upon completion of the first tranche of the Offering, the Acquiror will own, directly and indirectly, 3,001,000 Common Shares of the Issuer representing approximately 20.20% of the Issuer's issued and outstanding Common Shares on a non-diluted basis. If the Acquiror were to exercise all of her convertible securities she would own, directly and indirectly, 4,653,250 Common Shares, representing approximately 28.19% of the Issuer's then outstanding Common Shares, on a partially diluted basis.

The securities were acquired for investment purposes. The Acquiror currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Issuer's business and financial condition and/or other relevant factors, the Acquiror may develop such plans or intentions in the future.

The Acquiror entered into a subscription agreement with the Issuer to acquire 104,500 Units at a price of \$0.05 per Unit. Each Unit is comprised of one Common Share and one-half of one Warrant. Each Warrant entitles the Acquiror to purchase one Common Share at an exercise price of \$0.10 per Common Share for a period of twenty four months from the closing of the Offering.
