On November 24, 2017, Judith Kalyan, Chief Executive Officer and a Director of the Issuer, disposed of a total of 10,988,888 Shares at a price of \$0.01 per Share pursuant to the terms of an agreement (the “Share Purchase Transaction”).

On November 24, 2017, Ms. Kalyan disposed of 10,988,888 Shares. Ms. Kalyan’s proportionate share of the issued and outstanding Shares decreased from 36.4% to 26.1%.

Following the completion of the Share Purchase Transaction, Ms. Kalyan owned 27,625,000 Shares, approximately 26% of the issued and outstanding Shares.

Ms. Kalyan has entered into an agreement to dispose of up to 38 million shares over three (3) tranches to close on or before January 15, 2018. The first tranche closed on November 24, 2017, and Ms. Kaylan disposed of 10,988,888 shares on that day.
