This report relates to 6,900,000 common shares (the “**Sold Shares**”) in the capital of IC Potash Corp. (the “**Company**”) sold by Resource Capital Fund V L.P. (“**RCF V**”) and Resource Capital Fund VI L.P. (“**RCF VI**”), collectively. RCF V and RCF VI are under common management and are referred to herein together as “**RCF**”.

RCF sold the Sold Shares through the facilities of the TSX on July 12, 2017 for total gross proceeds of CAD\$221,490.00.

Of the total Sold Shares, 6,141,000 common shares in the capital of the company (each, a “**Common Share**”) were sold by RCF V and 759,000 Common Shares were sold by RCF VI.

Immediately following the disposition of the Sold Shares, RCF owned and controlled, directly or indirectly, 18,896,000 Common Shares, representing approximately 7.97% of the current issued and outstanding Common Shares.

RCF disposed of ownership and control of the Sold Shares.
