MANAGEMENT'S RESPONSIBILITY FOR FINANCIAL REPORTING

This interim management's discussion and analysis ("MD&A") reports on the operating results and financial condition of Quadron Capital Corporation (the "Company" or "Quadron") for the six months ended October 31, 2016 and is prepared as at December 30, 2016. This interim MD&A should be read in conjunction with the Company's audited annual financial statements for the years ended April 30, 2016 and 2015 and the notes thereto which were prepared in accordance with International Financial Reporting Standards ("IFRS") as issued by the International Accounting Standard Board ("IASB"), together with the unaudited condensed interim consolidated financial statements as at and for the six months ended October 31, 2016, which were prepared in accordance with IFRS and in accordance with International Accounting Standards ("IAS") 34, Interim Financial Reporting (collectively referred to as the "Financial Statements"). Other information contained in these documents has also been prepared by management and is consistent with the data contained in the Financial Statements.

All dollar amounts referred to in this MD&A are expressed in Canadian dollars except where indicated otherwise.

OVERVIEW AND OUTLOOK

Quadron Capital Corporation (the "Company" or "Quadron") was incorporated under the British Columbia Business Corporations Act on November 7, 2011 and became a reporting issuer in British Columbia and Alberta on July 25, 2012. The Company's head office is located at Suite 1600, 609 Granville Street, Vancouver, BC, V7Y 1C3, and it's registered and records office is located at Suite 885 W Georgia St #2200, Vancouver, BC, V6C 3E8. The Company's shares are not currently publicly traded.

The Company operates through its two wholly owned subsidiaries, Soma Labs Scientific Inc. ("Soma Labs") and Greenmantle Products Limited ("Greenmantle").

Ancillary Cannabis Businesses –the "Picks and Shovels" sector

The cannabis industry is one of the fastest growing markets in North America. Ancillary businesses – those which do not directly handle the cannabis plant – are, and will continue to be – important to the industry's success, maturation and evolution. As legalization evolves, and as commercial cannabis production expands, solutions are required to address the growing needs of this burgeoning industry.

Quadron, through its subsidiaries, is responding to this need by developing a scalable business model focussing on ancillary businesses and products which complement the established cannabis cultivation industry. Quadron is well-positioned to take advantage of existing opportunities and provide solutions to commercial cannabis cultivators and processors.

Cannabis extractions and ancillary devices

As consumer preference shifts from dried cannabis to extracted cannabis products, there is a great need for companies which design, engineer and fabricate specialized cannabis extraction and processing equipment. Few, if any, established industry leaders specialize in commercial level extraction, processing and manufacturing of cannabis products. Through its subsidiary, Soma Labs, the Company designs, manufactures, tests and customizes extraction equipment and consumption devices (hardware) for the cannabis industry. Soma Labs' industry-leading production standards, processes and recommendations ensure some of the world's finest extracts and products using Soma Labs branded extraction systems.

Flowing from the increasing popularity for cannabis extractions, consumers are seeking healthier methods for consuming, intaking and ingesting extracted products. Quadron's subsidiary, Greenmantle, designs and sources ancillary products and devices, which it wholesales and distributes to processors and industry participants operating in the cannabis space. These products include vaporization pens and cartridges, inhalers and capsules, as well as a variety of other consumption devices, including packaging for the products.

The Company's ancillary devices and extraction/processing equipment have been very well received by the market. Revenues and margins have grown from \$166,823 with \$47,099 gross margin for the year ended April 30, 2016, to \$429,180 in revenue and \$294,887 in gross margin for the current quarter ended October 31, 2016, resulting in net income of \$148,533 for the quarter. Revenue for the six months ended October 31, 2016 was \$652,630.

Cannabis odour abatement

Odour control is a serious problem for many cannabis production facilities. In jurisdictions where cannabis is legalized, most formal complaints against cultivation facilities are odour related. Although cannabis does not emit a toxic smell, as legalization of cannabis increases, regulations around odour abatement will likely also increase under local bylaws and regulations, making odour abatement a priority for cultivators. In addition, effective odour control goes a long way to creating neighborhood goodwill.

Quadron, through its subsidiary Soma Labs, is responding to this need by working with Odorchem Manufacturing Corp ("Odorchem") to produce high quality non-toxic odour control products for industrial, commercial and residential applications. Pursuant to a three-year services agreement that will provide the Company with up to \$1,500,000 in revenue, Soma Labs is providing research for the scientific development of new odour control processes and formulations for Odorchem. As a complement to the partnership with Odorchem, Greenmantle will also distribute Odorchem's odour abatement solutions to the cannabis industry.

Listing

On November 25, 2016, the Company filed and obtained a receipt from the British Columbia Securities Commission for its Final Non-Offering Prospectus. The Company also received conditional approval from the Canadian Securities Exchange (the "CSE") for the listing of its common shares on the CSE subject to the completion of customary requirements of the CSE. Once final approval is received, the common shares of Quadron will commence trading under the trading symbol: QCC.

AMALGAMATION

Effective January 8, 2016, Quadron acquired all the issued and outstanding share capital of Soma Labs. As consideration, Quadron issued 17,422,500 common shares and 2,000,000 preferred shares in exchange for all common and preferred shares of Soma Labs issued and outstanding immediately prior to the completion of the amalgamation. The Company also issued one warrant for each Soma Labs warrant held immediately prior to the date of the completion of the amalgamation (4,361,250 warrants issued). The warrants had an original value, and value on reissuance, of \$nil.

The Acquisition has been accounted for as an asset acquisition. The Acquisition is not considered a reverse takeover. Soma Labs' results of operations are included in the Company's consolidated results from January 8, 2016, onwards.

The fair value of the common and preferred shares issued in connection with this amalgamation was \$1,742,250. The excess of \$1,155,903 over the fair value of Soma Labs' net assets was allocated as a share-based payment in the 2016 fiscal year.

The annual financial results reflect the Company's minimal levels of activity during the 2014 and 2015 fiscal years as management conducted due diligence on potential new business ventures. During the 2016 fiscal year, Quadron amalgamated with Soma Labs; through Soma Labs, Quadron entered a three-year services agreement with Odorchem which is expected to provide total revenue of up to \$1,500,000 to Quadron. A large portion of the comprehensive loss for the 2016 fiscal year can be attributed to a one-time share-based payment of \$1,155,903 which was the excess of the fair value of the Quadron shares issued upon amalgamating with Soma over the fair value of Soma's net assets. In addition to the amalgamation, Quadron incorporated Greenmantle through which it created a cannabis-related product division that acts as a distribution channel which sources and sells ancillary devices (i.e. vaporizer pens) and other products and equipment to cannabis industry participants. Through Soma Labs, Quadron acquired extraction and processing equipment that it plans to lease and/or sell to licensed 3rd parties operating in the cannabis industry. During the 2016 fiscal year Soma Labs and Greenmantle generated \$166,823 in gross revenue.

RESULTS OF OPERATIONS FOR THE THREE MONTHS ENDED OCTOBER 31, 2016

The following is an analysis of the Company's operating results for the three months ended October 31, 2016, and includes a comparison against the three months ended October 31, 2015.

Net and comprehensive income/(loss) for the three months ended October 31, 2016 amounted to \$148,533 or \$0.00 per share (2015 – \$(28,282) or \$(0.00) per share) based on a weighted average number of common shares outstanding of 36,500,000 (2015 - 7,800,000).

Sales revenue for the three months ended October 31, 2016 was \$429,180 (2015 – \$nil). This revenue was generated from two divisions of the Company; a contract between Soma Labs and Odorchem to provide laboratory, research and development services and through Greenmantle from sales of ancillary devices (i.e. vaporizer pens) and other products and equipment to cannabis industry participants.

Cost of sales for the three months ended October 31, 2016 was \$134,293 (2015 – \$nil). These costs are reflective of the cost of labor involved in providing laboratory, research and development services and the cost of inventory involved in the sale of ancillary devices to cannabis industry participants.

Accounting and legal expenses for the three months ended October 31, 2016 were \$30,900 (2015 – \$26,600). The expense for the current period was for audit fees paid to have Soma's records audited to April 30, 2015 which was a requirement of filing a prospectus with the BCSC.

Bank charges for the three months ended October 31, 2016 were \$1,762 (2015 – \$nil). These fees related to the maintenance of the Company's bank account and charges for wire payments made to vendors.

Consulting fees for the three months ended October 31, 2016 were \$32,994 (2015 – \$nil). The fees related to management's efforts to source additional business opportunities to enhance and supplement the amalgamated entities' current business model.

Depreciation expense for the three months ended October 31, 2016 was \$19,584 (2015 – \$nil). Depreciation is the amortization of the cost of the CO₂ extractor and its related components and computer equipment purchased during the previous fiscal year.

Filing fees for the three months ended October 31, 2016 were \$3,062 (2015 - \$1,679). These amounts reflect the cost of maintaining a public company and overall these costs have remained consistent.

General and administrative expenses for the three months ended October 31, 2016 were \$131 (2015 – \$3). These expenses are significantly higher in the current period due to the finalization of the Acquisition in the previous fiscal year and the incorporation of Greenmantle where general and administrative expenses incurred by Soma and Greenmantle are now included as part of the amalgamated entity's financial activity.

Management fees for the three months ended October 31, 2016 were \$22,500 (2015 – \$nil). These expenses include fees paid to an external company for accounting services and administrative maintenance of the Company's books and records.

Marketing and research expenses for the three months ended October 31, 2016 were \$2,883 (2015 – \$nil). These expenses include costs involved in the marketing of the Company's products to potential customers and researching new ancillary products that could be used by licensed cannabis industry participants.

Remuneration and benefits expenses for the three months ended October 31, 2016 were \$40,259 (2015 – \$nil). These expenses are for wages paid to employees of Soma who are responsible for customer service, inventory control, laboratory maintenance and sales management.

Interest income for the three months ended October 31, 2016 was \$7,721 (2015 – \$nil). This interest income was generated from the outstanding promissory note from Odorchem valued at \$450,000 with an interest rate of 5.5% per year.

RESULTS OF OPERATIONS FOR THE SIX MONTHS ENDED OCTOBER 31, 2016

The following is an analysis of the Company's operating results for the six months ended October 31, 2016, and includes a comparison against the six months ended October 31, 2015.

Net and comprehensive income/(loss) for the six months ended October 31, 2016 amounted to \$128,682 or \$0.00 per share (2015 – \$(29,836) or \$(0.00) per share) based on a weighted average number of common shares outstanding of 36,500,000 (2015- 7,800,000).

Sales revenue for the six months ended October 31, 2016 was \$652,630 (2015 – \$nil). This revenue was generated from two divisions of the Company; a contract between Soma Labs and Odorchem to provide laboratory, research and development services and through Greenmantle from sales of ancillary devices (i.e. vaporizer pens) and other products and equipment to cannabis industry participants.

Cost of sales for the six months ended October 31, 2016 was \$225,841 (2015 – \$nil). These costs are reflective of the cost of labor involved in providing laboratory, research and development services and the cost of inventory involved in the sale of ancillary devices to cannabis industry participants.

Accounting and legal expenses for the six months ended October 31, 2016 were \$40,900 (2015 – \$28,100). The expense for the current period was for audit and legal fees associated with filing a prospectus with the BCSC.

Bank charges for the six months ended October 31, 2016 were \$3,750 (2015 – \$nil). These fees related to the maintenance of the Company's bank account and charges for wire payments made to vendors.

Consulting fees for the six months ended October 31, 2016 were \$66,094 (2015 – \$nil). The fees related to management's efforts to secure additional business opportunities to enhance and supplement the amalgamated entities' current business model.

Depreciation expense for the six months ended October 31, 2016 was \$38,817 (2015 – \$nil). Depreciation is the amortization of the cost of the CO₂ extractor and its related components and computer equipment purchased during the previous fiscal year.

Filing fees for the six months ended October 31, 2016 were \$3,062 (2015 - \$1,679). These amounts reflect the cost of maintaining a public company and overall these costs have remained consistent.

General and administrative expenses for the six months ended October 31, 2016 were \$19,195 (2015 – \$57). These expenses are significantly higher in the current period due to the finalization of the Acquisition in the previous fiscal year and the incorporation of Greenmantle where general and administrative expenses incurred by Soma and Greenmantle are now included as part of the amalgamated entity's financial activity.

Management fees for the three months ended October 31, 2016 were \$45,000 (2015 – \$nil). These expenses include fees paid to an external company for accounting services and administrative maintenance of the Company's books and records.

Marketing and research expenses for the three months ended October 31, 2016 were \$30,372 (2015 – \$nil). These expenses include costs involved in the marketing of the Company's products to potential customers and researching new ancillary products that could be used by licensed cannabis industry participants.

Remuneration and benefits expenses for the three months ended October 31, 2016 were \$65,267 (2015 – \$nil). These expenses are for wages paid to employees of Soma who are responsible for customer service, inventory control, laboratory maintenance and sales management.

Interest income for the three months ended October 31, 2016 was \$14,350 (2015 – \$nil). This interest income was generated from the outstanding promissory note from Odorchem valued at \$450,000 with an interest rate of 5.5% per year.

RISKS AND UNCERTAINTIES

Lack of Dividend Policy

The Company does not presently intend to pay cash dividends in the foreseeable future, as any earnings are expected to be retained for use in developing and expanding its business. However, the actual amount of dividends from the Company will remain subject to the discretion of the Company's Board of Directors and will depend on results of operations, cash requirements and future prospects of the Company and other factors.

Possible Dilution to Present and Prospective Shareholders

The Company's plan of operation, in part, contemplates the accomplishment of business negotiations by the issuance of cash, securities of the Company, or a combination of the two, and possibly, incurring debt. Any transaction involving the issuance of previously authorized but unissued common shares would result in dilution, possibly substantial, to present and prospective holders of common shares.

Dependence of Key Personnel

The Company strongly depends on the business and technical expertise of its management and key personnel. There is little possibility that this dependence will decrease in the near term. As the Company's operations expand, additional general management resources will be required. These personnel will be central to the Company's ability to locate and develop business opportunities.

Conflicts of Interest

Certain of the directors and officers of the Company will be engaged in, and will continue to engage in, other business activities on their own behalf and on behalf of other companies and, as a result of these and other activities, such directors and officers of the Company may become subject to conflicts of interest. The British Columbia Business Corporations Act ("BCBCA") provides that in the event that a director has a material interest in a contract or proposed contract or agreement that is material to the issuer, the director must disclose his interest in such contract or agreement and refrain from voting on any matter in respect of such contract or agreement, subject to and in accordance with the BCBCA. To the extent that conflicts of interest arise, such conflicts will be resolved in accordance with the provisions of the BCBCA.

Litigation

The Company and/or its directors may be subject to a variety of civil or other legal proceedings, with or without merit.

OFFICERS AND DIRECTORS

Certain directors of the Company are also directors, officers and/or shareholders of other companies that are similarly engaged in the business of identifying and evaluating new investment and acquisition opportunities. Such associations may give rise to conflicts of interest from time to time. The directors of the Company are required to act in good faith with a view to the best interests of the Company and to disclose any interest which they may have in any project opportunity of the Company. If a conflict of interest arises at a meeting of the Board of Directors, any director in a conflict will disclose his/her interest and abstain from voting in the matter(s). In determining whether or not the Company will participate in any project or opportunity, the directors will primarily consider the degree of risk to which the Company may be exposed and its financial position at the time.

LIQUIDITY AND CAPITAL RESOURCES

The Company defines capital that it manages as cash and equity (consisting of issued common shares). The Company manages its capital structure and makes adjustments to it, based on the funds available to the Company, to fund existing operations and the search for new business opportunities in order to provide returns to its shareholders. The Company does not establish quantitative return on capital criteria for management, but rather relies on the expertise of the Company's management to sustain the future development of the business. The Company manages and adjusts its capital structure as a result of changes in economic conditions. Management reviews its capital management approach on an ongoing basis and believes that this approach, given the relative size of the Company, is reasonable. The Company is not subject to any externally imposed capital requirements or debt covenants. There was no change to the Company's approach to capital management during the six-month period ended October 31, 2016.

As at October 31, 2016, the Company had working capital of \$740,698 (April 30, 2016 – \$583,716) including cash and cash equivalents that totaled \$172,818 (April 30, 2016 - \$662,960). Working capital is held almost entirely in cash and cash equivalents, significantly reducing any liquidity risk of financial instruments held by Quadron. As at October 31, 2016, the Company had two sources of revenue; the first being the provision of research and laboratory services to the biotech and biocetical industries, and the second source being the sale of ancillary products and equipment to cannabis industry participants; both revenue streams will further reduce the Company's liquidity risk. The future success of the Company is dependent on the growth of the existing businesses of Greenmantle and Soma Labs. The Company expects to incur further losses as it grows its existing business and as it pursues other complementary business opportunities. The closing of the financings in November 2015 and December 2015 position the Company to continue the planned expansion of its activities and to continue to pursue other complementary business opportunities. However, the Company may require additional financing to accomplish its long term strategic objectives. There can be no certainty of the Company's ability to raise additional financing if needed. If the Company is unable to finance itself, and its revenue streams remain limited, it is possible that the Company will be unable to continue as a going concern.

The Company's financial statements have been prepared in accordance with IFRS under the assumption that the Company will be able to realize its assets and discharge its liabilities in the normal course of business rather than a process of forced liquidation. Cash flows used in operating activities were \$479,625 for the six months ended October 31, 2016 compared to \$1,623 during the six months ended October 31, 2015. The increased use of cash was primarily due to the Company's amalgamation with Soma Labs and the incorporation of its wholly-owned subsidiary Greenmantle in Q3 2016. Cash was expended to pay for inventory, new employees and the management required to run the new divisions of the Company. Cash was also expended for marketing to attract new customers to its product lines and for research of potentially new product lines.

Cash flows used in investing activities were \$10,517 for the six months ended October 31, 2016 compared to \$74,000 for the six months ended October 31, 2015. Cash flows used were the result of the purchase of the new equipment.

FINANCIAL INSTRUMENTS

a) Fair value risk

The Company's financial instruments consist of cash and cash equivalents, accounts receivable, promissory note, GST recoverable, accounts payable and accrued liabilities and amounts payable to related parties.

The Company's financial instruments with the exception of cash and cash equivalents approximate their fair value due to their short-term maturities and with respect to the promissory note due to its market value and interest rate. The Company's other financial instrument, cash, is classified as fair value through profit or loss under the fair value hierarchy based on level one quoted prices in active markets for identical assets or liabilities.

b) Market risk

Market risk is the risk that the fair value or future cash flows from a financial instrument will fluctuate because of changes in market prices or prevailing conditions. Market risk comprises three types of risk: currency risk, interest rate risk and price risk and are disclosed as follows:

(i) Currency risk

Currency risk is the risk of change in profit or loss that arises from fluctuations of foreign exchange rates and the degree of volatility of these rates. The Company does not use derivative instruments to reduce its exposure to foreign currency risk. The Company has only a nominal amount of assets or liabilities denominated in foreign currencies and engaged in very few transactions denominated in a foreign currency; therefore, its exposure to foreign exchange risk is limited.

(ii) Interest rate risk

The Company is not exposed to interest rate risk because it does not have any assets or liabilities that are affected by changes in interest rates except for cash and cash equivalents which poses an insignificant risk exposure to changes in interest rates.

(iii) Price risk

The Company has limited exposure to price risk with respect to equity prices. Equity price risk is defined as the potential adverse impact on the Company's earnings due to movements in individual equity prices or general movements in the level of the stock market.

c) Credit risk

Credit risk is the risk of an unexpected loss if a customer or third party to a financial instrument fails to meet its contractual obligations.

All the Company's cash and cash equivalents are held through a Canadian chartered bank and accordingly, the Company's exposure to credit risk is considered to be limited. The Company's GST recoverable are refunds due from the Government of Canada and the exposure to credit risk on these amounts are considered to be limited. The Company's current accounts receivable consists of amounts due from its contract with Odorchem (considered fully collectible) and various other customers (amounts considered fully collectible); however, these receivables do pose a moderate credit risk. The promissory note is secured by a General Security Agreement and the exposure to credit risk on this note is limited.

d) Liquidity risk

Liquidity risk is the risk that the Company will not be able to meet its financial obligations as they fall due. At October 31, 2016, the Company has a cash and cash equivalents balance of \$172,818 to settle current liabilities of \$166,188. The Company manages its liquidity risk by attempting to maintain sufficient cash and cash equivalents balances to enable settlement of transactions on the due date. Accounts payable and accrued liabilities are all current. As the Company has limited sources of revenue, it may require additional financing to accomplish its long term strategic objectives. On November 6, 2015 the Company closed on a non-brokered private placement of 6,640,000 units at \$0.10 per unit for gross proceeds of \$664,000 and on December 31, 2015 the Company closed on a non-brokered private placement of 4,637,500 units at \$0.10 per unit for gross proceeds of \$463,750. The Company is using the proceeds from these private placements and the income from operations to fund operating activities and pursue other complementary business opportunities.

CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS

The preparation of the financial statements in conformity with International Financial Reporting Standards ("IFRS") requires management to make estimates, judgements and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimates are revised and in any future periods affected.

(a) Critical accounting estimates

Critical accounting estimates are estimates and assumptions made by management that may result in a material adjustment to the carrying amount of assets and liabilities within the next financial year and they include:

(i) Income taxes

Tax provisions are based on enacted or substantively enacted laws. Changes in those laws could affect amounts recognized in profit or loss both in the period of change, which would include any impact on cumulative provisions, and in future periods. Deferred tax assets (if any) are recognized only to the extent it is considered probable that those assets will be recoverable. This involves an assessment of when those deferred tax assets are likely to reverse and a judgment as to whether or not there will be sufficient taxable profits available to offset the tax assets when they do reverse. This requires assumptions regarding future profitability and is therefore inherently uncertain. To the extent assumptions regarding future profitability change, there can be an increase or decrease in the amounts recognized in respect of deferred tax assets as well as the amounts recognized in profit or loss in the period in which the change occurs.

(ii) Stock options and warrants

Determining the fair value of warrants and stock options requires estimates related to the choice of a pricing model, the estimation of stock price volatility, the expected forfeiture rate and the expected term of the underlying instruments. Any changes in the estimates or inputs utilized to determine fair value could have a significant impact on the Company's future operating results or on other components of shareholders' equity (deficiency).

(iii) Inventories

Inventories are valued at the lower of cost and net realizable value. Cost of inventory includes cost of purchase (purchase price, import duties, transport, handling, and other costs directly attributable to the acquisition of inventories), and other costs incurred in bringing the inventories to their present location and condition. Net realizable value for inventories is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale. Provisions are made in profit or loss in the period for any difference between book value and net realizable value.

(iv) Equipment

The estimated useful lives of assets are reviewed by management and adjusted if necessary. To estimate equipment's useful life, management must use its experience with the same or similar assets, review engineering estimates and industry practices for similar pieces of equipment and apply statistical methods to assist in its determination of useful life.

(v) Determination of market value of Quadron common shares

As the Company is only a reporting issuer and not currently publicly traded, management must estimate the fair market value of the Company's shares when using its shares to procure assets or financing. Management can estimate the market value by comparing other public companies of a similar size and nature as Quadron and applying some of their metrics to Quadron's current situation.

The information about significant areas of judgment considered by management in preparing the financial statements is as follows:

(i) Going concern

The assessment of the Company's ability to continue as a going concern as discussed in Note 1 involves judgment regarding future funding available for its operations and working capital requirements.
