On July 4, 2016 the Acquiror acquired an aggregate of 3,153,919 units (“**Units**”) in a private placement of the Issuer at a price of \$0.15 per Unit (the “**Offering**”). Each Unit is comprised of one Common Share and one Common Share purchase warrant (a “**Warrant**”).

Item 3 – Interest in Securities of the Reporting Issuer

The Acquiror acquired an aggregate of 3,153,919 Units of the Issuer. The Units are comprised of 3,153,919 Common Shares and 3,153,919 Warrants. The 3,153,919 Common Shares and 3,153,919 Warrants, comprising the Units, represent approximately 12.40% of the issued and outstanding Common Shares of the Issuer and 44.17% of the Warrants issued, respectively.

Prior to the completion of the Offering, the Acquiror, directly and indirectly, owned 3,564,800 Common Shares of the Issuer representing approximately 19.12% of the issued and outstanding Common Shares of the Issuer.

Upon completion of the Offering, the Acquiror will own, directly and indirectly, 6,718,719 Common Shares of the Issuer representing approximately 26.42% of the Issuer's issued and outstanding Common Shares on a non-diluted basis. If the Acquiror were to exercise all of his convertible securities he would own, directly and indirectly, 10,562,638 Common Shares, representing approximately 36.10% of the Issuer's then outstanding Common Shares, on a partially diluted basis.

\$0.15 per Unit, for an aggregate total consideration of \$473,087.85, of which \$198,000 was paid in cash and \$275,087.95 was paid by way of settling existing bona fide debt.

The Acquiror acquired an aggregate of 3,153,919 Units in the Offering at a purchase price of \$0.15 per Unit, of which 1,320,000 Units were issued for cash and 1,833,919 Units were issued in respect of settling existing bona fide debt.

The securities were acquired for investment purposes. The Acquiror currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Issuer's business and financial condition and/or other relevant factors, the Acquiror may develop such plans or intentions in the future.

The Acquiror entered into a subscription agreement with the Issuer to acquire an aggregate of 3,153,919 Units at a price of \$0.15 per Unit. Each Unit is comprised of one Common Share and one Warrant. Each Warrant entitles the Acquiror to purchase one additional common share in the capital of the Issuer at an exercise price of \$0.30 per common share for a period of twenty four months from the closing of the Offering.
