THC Announces \$1.3 Million Private Placement with Alumina Partners

Vancouver, British Columbia – (February 9, 2018) THC BioMed Intl Ltd. (CSE: THC), ("THC" or the "Company") is pleased to announce that the Company closed a private placement, under its previously announced investment agreement, with Alumina Partners (Ontario) Ltd. ("Alumina").

On February 8, 2018, the Company issued to Alumina 1,002,673 units ("Units") at a price of \$1.328 per Unit, for total proceeds of \$1,331,551. Each unit consists of one common share and one common share purchase warrant. Each warrant entitles the holder to purchase one common share of the Company for a period of 36 months from closing at a price of \$2.08 per share.

The proceeds of this private placement will be used for potential expansion of THC internationally and within Canada. The proceeds will also be used towards general working capital.

This brings the total raised through the Alumina private placements to \$6,031,552.62.
