On April 20, 2017, Palisade purchased 109,000 shares of Tartisan Resources Corp (“**Tartisan**”) at an average price of .132 through open market purchases on the Toronto Venture Exchange. In addition, On April 21, 2017, Palisade exercised 5,000,000 warrants of Tartisan (a “**Tartisan Warrant**”), at a price of .07 cents each. Following the exercise of the Tartisan Warrants, Palisade now

owns 10,109,000 common shares of Tartisan (a “**Tartisan Share**”), representing approximately 14.43% of Tartisan’s issued and outstanding common shares. Palisade holds no additional warrants of Tartisan following the exercise.
