

THE ALKALINE WATER COMPANY ENGAGES SRAX, INC.

SCOTTSDALE, Ariz. — August 14, 2020 — The Alkaline Water Company Inc. (NASDAQ and CSE: WTER) (the "Company"), is a producer of premium bottled alkaline water, flavored-infused waters, and CBD-infused products sold under the brand names Alkaline88®, A88 Infused™, and A88CBD™, respectively. Today, the Company announced it has entered into a platform account contract agreement (the "Agreement") dated effective July 30, 2020 with SRAX, Inc. ("SRAX"), whereby the Company engaged SRAX to provide investor relations management services through its online platform (the "Services") for the Company for an initial term beginning on August 3, 2020 and ending on November 3, 2020 (the "Term"), unless extended in accordance with the Agreement. In consideration of SRAX agreeing to provide the Services and enter into the Agreement, the Company agreed to pay a one-time annual platform access fee in the amount of \$40,000 plus pay for additional deliverables during the Term in the amount of \$115,000 for a total of \$155,000 with the consideration being paid by the issuance of 90,116 shares of common stock of the Company at a deemed price of \$1.72 per share, being the closing price of the Company's stock on the Nasdaq Capital Market on August 14, 2020.
