**Fiorentina Minerals Inc. Completes Initial Public Offering**

**Vancouver, British Columbia, October 18, 2019:** Fiorentina Minerals Inc. (the "Company" or "Fiorentina") (CSE: FLO) is pleased to announce that on October 18, 2019, it completed its initial public offering (the "IPO") of 4,006,000 common shares in its capital (each a "Share"), 506,000 of which were sold pursuant to an over-allotment option, at a price of \$0.10 per Share for gross proceeds of \$400,600. The net proceeds from the IPO will be used for working capital and to carry out exploration of the Company's Consortium Project Mineral Property located approximately 35 kilometres south of the town of Sayward on Vancouver Island, British Columbia, in the Nanaimo Mining Division.

Leede Jones Gable Inc. acted as agent (the "Agent") for the IPO. The Agent received a cash commission equal to 10% of the gross proceeds of the IPO and a corporate finance fee of \$25,000. Additionally, the Company granted the Agent and its selling group compensation options entitling the holder to purchase in aggregate 400,600 Shares at a price of \$0.10 per Share, exercisable on or before October 18, 2021.

The Shares were approved for listing on the Canadian Securities Exchange on October 16, 2019 and are expected to begin trading on October 21, 2019 under the symbol "FLO".

The offered securities have not been and will not be registered under the United States *Securities Act of 1933*, as amended (the "U.S. Securities Act"), or any applicable state securities laws and may not be offered or sold in the United States or to "U.S. persons", as such term is defined in Regulation S under the U.S. Securities Act, absent such registration or an applicable exemption from such registration requirements.
